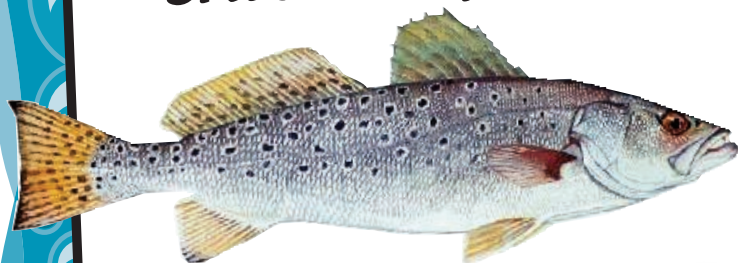

# TOURNAMENT RULES & REGULATIONS

1. All participants are subject to polygraph testing at any time for any reason. Failure to take the polygraph or failing to pass it will be an automatic disqualification of this and future events.
2. Registration: \$125.00 per boat. \$40 entry fee for BIG FISH PRIZE, with an 50/30/20 split for BIG FISH PRIZE. Entry fees are non-refundable.
3. Mailed entries will not be checked after 10/13/2007. \$40 Late registration fee. All entries after 10/13/07 will be paid in cash at the captains meeting.
4. There will be 2 check-in/launch sites, Caspers Marine in Swansboro on the ICW at channel marker 46-C and New River Marina in Sneads Ferry at channel marker #4 RED.
5. Check-in, weigh-in site, dinner and awards located at New River Marina / Power Marine Outfitters.
6. Fishing time to be determined by safe light and will be given at registration.
7. Speckled trout only. **10 Fish limit per boat.** All fish must be at least 12" long. Attempting to weigh in short fish will result in loss of that fish plus your Big Fish.
8. A late penalty of 1lb. per minute will be subtracted. After 15 minutes, that boat will be disqualified.
9. All boats will have adequate safety gear.
10. Tournament will be held regardless of conditions, the discretion of the tournament committee will determine that conditions are safe.
11. All fish will be caught by hook and line only. No gill nets are allowed on boats. All boats will return to dock under their own power.
12. Fish will be fresh and pass inspection of tournament committee. All fish weighed become property of tournament.
13. Scales will open at 4:00 PM. All participants will be returned to the dock by 4:15pm
14. All protests will be bought before the tournament committee, no later than 15 minutes after the scales close.
15. All decisions made by the tournament committee will be final.
16. Failure to comply with any tournament rule will result in automatic disqualification.
17. There will be a Captains meeting Friday the 19th day of October, 2007 at 6:45 PM at the Marina Cafe, 110 S. Marine Blvd., Jacksonville (910) 938.2002. It is Mandatory for at least one (1) of the teams member to show for the reading of the rules and regulations.
